Articulation Agreement:
Associate of Applied Science in Radiography
Awarded by Trinity College of Nursing & Health Sciences

Trinity College of Nursing & Health Sciences of Rock Island, IL, and **Black Hawk College of Moline, IL** (the Parties) believe that a cooperative program benefits students by allowing students an opportunity to prepare for transfer to the Associate of Applied Science in Radiography.

This Articulation Agreement (the Agreement) between the Parties is for qualified students taking prerequisite and general education courses at Black Hawk College to transfer to Trinity College of Nursing & Health Sciences to complete their Associate of Applied Science (AAS) degree in Radiography.

Agreement

The Agreement is designed to provide participating students with a specific pathway to transfer from Black Hawk College to the AAS in Radiography at Trinity College of Nursing & Health Sciences.

It is agreed and understood that each institution has the right and responsibility to make changes to its curricula, admission, enrollment, and graduation standards to maintain its academic integrity and meet accreditation standards. Such changes, if any, will be communicated in writing to the other Party at least 90 days prior to the effective date of the respective change.

At the request of either institution, a meeting or conference will be held to resolve any problems and monitor progress under the terms of this Agreement.

Under the terms of this Agreement, neither institution is obligated to make any payments of any kind to the other institution.

Academic Requirements

- 1. For admission to the AAS in Radiography at Trinity College of Nursing & Health Sciences, all applicants must complete and earn a C or better in a college level math course and BIOL 145 Anatomy & Physiology I (A&P I), and one of these options:
 - a) high school minimum GPA of 2.5 and ACT composite score of 20, or

- b) SAT composite score of 1020, or
- c) 12 semester college level credits with a minimum GPA of 2.5. The college math and A&P I may be counted toward the 12 credits. Any other college level course can be taken to complete 12 credits for admission purposes.
- 2. The AAS in Radiography includes 54 credits in Radiography and 23 credits in pre-requisite and general education courses for a program total of 77 credits. Refer to Appendix A.
- 3. Students must earn a minimum of 23 semester hours of pre-requisite and general education courses from Black Hawk College. Except for the math and the A&P I required for admission, courses can be completed before transfer to Trinity or during the AAS Radiography curriculum. For approved courses refer to Appendix B.
- 4. To award transfer credit, Trinity will evaluate official transcripts at the time of application and for any subsequent term during which the student transfers general education courses and provides an updated official transcript. All transferred courses require a grade of C or better. Approved transfer credit is applied to the student's official Trinity record at the time of evaluation. Students who register for a course through Trinity do not need to present official transcripts.
- 5. Trinity College of Nursing & Health Sciences will verify the student has successfully completed the AAS in Radiography program (77 total credits) and is eligible to take the American Registry of Radiologic Technologists (ARRT) national certification exam.
- 6. Students who successfully complete the AAS in Radiography program at Trinity College of Nursing & Health Sciences (77 total credits) will be eligible to participate in Trinity's commencement.

Accreditation

The Parties will ensure that they maintain accreditation with the Higher Learning Commission regional accrediting body. The Parties will ensure all operations will be in keeping with accreditation requirements of the two institutions.

Duration and Termination of Agreement

The Parties agree that this Agreement shall be in force the date of the signing of the Agreement and shall remain in force until modified or terminated in writing, following reasonable and mutual discussion by representatives of the Parties.

The Parties reserve the right to revise or eliminate programs and courses. Such changes will be communicated in writing to the appropriate parties noted in this section. This Agreement will be reviewed annually to ensure currency with each Party's degree requirements and may be modified by attachment.

Should this Agreement be terminated, for any student already admitted into the AAS Radiography Program, Trinity College of Nursing & Health Sciences will continue to apply the transferred pre-requisite and general education courses and credits to the AAS Radiography Program as specified in this Agreement provided the student continues to meet satisfactory academic progress toward their degree.

Trinity will annually report to BHC on the progress of students applying under this Agreement to include the following data for student cohorts beginning each first-year fall term: a) number of students who applied, b) number of students accepted and average transfer GPA, c) number of students who graduate. BHC also requests shared data be disaggregated by race/ethnicity to the extent possible. In sharing data, BHC and Trinity will comply with the Family Educational Rights and Privacy Act of 1974.
